DURING THE MONTH OF DECEMBER 2015, DURHAM AMBULANCE INC. WAS DISPATCHED TO 48 CALLS. OF THE 48, 36 WERE TRANSPORTS {20 BLS & 16 BLS}, 3 WERE RMA'S, 1 WAS A CALL CANCELED, 3 WERE TOT'D DUR TO 1<sup>ST</sup> CREW BEING OUT ALREADY, 2 WERE HELICOPTER TRANSFERS TO AMCH AND 3 WERE NO PATIENT FOUND.

WE HAD ANOTHER RECORD CALL VOLUME YEAR. LAST YEAR WE DID 620 CALLS. YEAR TO DATE TOTALS THIS YEAR ARE: 655 CALLS, OF WHICH, 446 WERE TRANSPORTS {205 BLS & 241 ALS}, 78 WERE RMA'S, 39 WERE CALL CANCELED, 18 WERE STANDBYS, 43 WERE TOT'D DUE TO 1<sup>ST</sup> CREW BEING OUT ALREADY, 6 WERE HELICOPTER TRANSFERS TO AMCH, 1 WAS AN OBVIOUS DEATH, 25 WERE NO PATIENT FOUND AND 1 WAS A CARDIAC ARREST SECURED ON THE SCENE.

BILLING, SCHEDULING AND PAYROLL ARE GOING WELL. BUILDING IS IN GOOD SHAPE. VEHICLES ARE IN GOOD SHAPE WITH NO PROBLEMS TO REPORT TO MY KNOWLEDGE. WE HAVE ORDERED THE NEW AMBULANCE. EXPECTED DELIVERY DATE IS FEBRUARY OR MARCH.

I ATTENDED THE GREENE COUNTY EMS COUNCIL MEETING AND THE GREENE EMS MEETING. THERE IS NOTHING NEW TO REPORT THERE. ELECTIONS FOR THE GREENE EMS BOARD WILL HAPPEN IN MARCH

I WAS CONTACTED BY JIM PURDY, STORE MANAGER FROM THE CAIRO HANNAFORD. HE INFORMED ME THE WE [DURHAM AMBULANCE INC.] WE HAVE BEEN SELECTED TO RECEIVE A DONATION FOR THE MONTH OF JANUARY. WE TOOK SOME PICTURES ON THURSDAY OF LAST WEEK THAT WERE SUPPOSED TO GET TO THE PAPERS. I WAS TRULY SURPRISED. I HAVE SENT LETTERS TO THEM IN THE PAST, THANKING THEM FOR THEIR DONATION TO EACH BBQ. THEY IN TURN SEND IT TO CORPORATE. I WILL DO THE SAME FOR THIS.

We service and repair the Walter Truck (Big Dog) for our spare truck in case of equipment breakdowns. We also worked on the 2002 & 2003 Paystar servicing the brakes, chassis and plow controls. The rear lights were repaired on the 2012 Western Star. Also the plow frame on the Chevy 4500 had rotten out. So we were able to replace it with one of our spare plow frames.

We have been able to do a lot of work in the shop. Cleaning and servicing our tools and made a rack for the storage of our road signs.

With weather cooperating we were able to change the tires on the Sterling Dump Truck.

The last two weeks we have been sanding and keeping up on the ice spots around town. The sidewalks were cleared after the Dec 29th storm.

I have been watching the Federal Surplus web site for equipment. A mid 90's John Deere 550 bulldozer became available for \$2,000. It is in fair to good condition. It has a fuel system leak that is easily repaired. I have request purchase. This unit can be moved around Town by us and we would not need to rent one for projects.

The pressure washer purchased from Keil Equip in 2006 has done its last job. I contacted vendors for cost of repair or replacement. It is more cost efficient to purchase a new one. I have attached copies of the four price quotes. Windham Equip has come in with the best price. The unit has been ordered. This piece of equipment is vital for maintaining our equipment to reduce deterioration of the frames and bodies.

I attended 6 hours of training by the NYSBOC for the installation of flexible gas piping for homes.

I have done a total of 8 construction inspections between GSK and Zoom Flume for their current projects.

I have been working with George Morehouse, NYS Code Enforcement-Manufacture Home Specialist, on 97 Cornwallville Road. We received a memo last August from the State notifying us on the requirements for the installation of manufacture homes. These requirements have been in effect for years but were not being followed by most of the building departments in NYS. David and I reviewed the memo and had multiple conversations regarding the requirements. I even reached out to Lucille Bertone, Cairo Mobile Homes, to see if she was aware of the requirements and she was. Basically the units need to be installed per the Installation Manual provided by the manufacture home company. The biggest concern is the slab has to meet the requirements or it will void the warranty on the home. The slab at 97 Cornwallville Rd is an existing slab, they cannot be grandfather, I placed a stop work order on the project to protect the homeowners until the slab could be brought up to the design required by the installation manual. This stop work order was done prior to the home being placed on the slab. During Christmas time the unit was brought in and placed on the slab. Due to confusion regarding these requirements I reached out to George and he visited the property with me on January 8th, 2016 to help us and the homeowners to become compliant for there new home.

I am currently on vacation. If more detail information is needed please speak with Bill, I have been keeping him up to date.


